This is intended to be a simple process that will take only minutes to complete. Please refer to these instructions if you have questions on how to complete your order form. Part 1 - Contact Information

Under *Legal Name of Company* include the type of company you operate. The options include:

- Limited Liability Companies (LLC)
- Sub Chapters S or C (Inc.)
- Limited Liability Partnerships (LLP)
- Sole Proprietorships (no initials after company name)

Part 2 - Identification of Service(s)

You need to determine the number of Waiver templates that will be necessary to construct as it is common for a diversified business to need more than one waiver. For instance, you may offer summer pack trips, float fishing and hunting in the fall. In this case, you will need three separate waivers. We need to avoid creating one massive waiver that attempts to cover all service for the year and ask people to sign them if they include services they are not involved with. Therefore, we have set the Order Form up to have Primary (Hunting, Fishing, Horseback, and Floating) and Ancillary (Camping, Food Service, Non-carrier shuttle, and Floating) options.

1. Primary Service(s)
 - A. Hunting (describe services and/or activity as hunting)
 - B. Fishing (describe services and/or activity as fishing)
 - C. Horseback (describe services and/or activity as horseback riding, trail rides or pack trips)
 - D. Floating (describes services and/or activity as boating, floating or other water-related activity)
2. Ancillary services done in conjunction with primary service (Can be included as part of the standalone waiver for hunting, fishing, horseback or floating)
 - A. For Horseback Hunts: Use hunting (primary) plus horseback (ancillary)
 - B. For Pack Trips: Use horseback (primary) plus camp (and fishing if provided) as ancillary
 - C. For Multi-Night Fishing: Use fishing plus camping
 - D. Add these paragraphs if they indicated that they provide these services as well:
 - i. Camping
 - ii. Food service
 - iii. Non-carrier shuttle

You will need to review them and taper them to your business. You may elect to involve your attorney as we suggest. **You must read and sign Part 4 and return it to the office with your payment before we will offer you the draft language.**
